How much will Awilco drill rig cost?

UK offshore drilling contractor Awilco Drilling has exercised an option to order its second harsh-environment semi-submersible drilling rig from Keppel in Singapore for a price of \$425 million. It has also decided to name a new CEO. The rig will be built to Moss Maritime's CS60 ECO MW design and is expected to be delivered in March 2022.

What is Awilco's new drilling rig?

Similar to the first rig, which Awilco ordered in March 2018, the drilling unit is designed for mid-water operations in water depths up to 1,500m and able to work in the harshest environments of North West Europe, including the Barents Sea. Awilco will have options to order two more rigs from Keppel.

Who owns Awilco Rig 2?

Awilco Drilling PLC(the Company) announces that its wholly owned subsidiary Awilco Rig 2 Pte. Ltd. (AR2) has today received a notice from Keppel FELS purporting to terminate the Vessel Construction Contract of the semi-submersible drilling rig Nordic Spring ("Notice"). Keppel FELS has also served AR2 with a notice of arbitration.

Does Awilco have a new CEO?

Does Awilco Rig 1 have a right to terminate a building contract?

Reference is made to our stock exchange release dated 8 June 2020 advising that Awilco Rig 1 Pte. Ltd. (AR1) has exercised its right to terminate the building contract with Keppel FELS Limited (KFELS) and is entitled to a refund of the instalments paid to KFELS plus accrued interest.
