Can a contractor commit a rig to a third party?

During the Primary Term and any Extension Terms, Contractor shall not contractually commit the Rig to any other party while this Drilling Contract is in effect unless the relevant time period for Operator to exercise its respective options pursuant to this Section 2.6 has expired.

Who is responsible for drilling a rig?

The drilling of each well shall be commenced without delay (unless such delay is ordered by Operator) after operations are completed at the previous well, if any. Contractor shall be responsible for the operation of the Rig, including moving operations and positioning on drilling locations as required by Operator.
