What should a drilling contract include?

A drilling contract should address the standard of performance expected of the drilling contractor. The API drilling contract form requires the contractor perform "with due diligence and care, in a good workmanlike manner, and in accordance with good drilling practices."

Parties involved in an offshore drilling contract typically include the driller, the operator, and the owner of the rig. Certain terms and conditions must be met in order for a contract to be valid, and disputes often arise over issues such as damages and breach of contract.

What are the different types of drilling contracts?

The Independent Association of Drilling Contractors (IADC) has its own set of drilling contracts, and they are commonly used. Most of the wells in the United States are drilled under one of the three major types of drilling contracts: the Turnkey, the Daywork, or the Footage contracts. Examples of all three of these contracts are in the workbook.

How do I pay for a drilling contract?

(a) Subject to the terms and conditions of this Drilling Contract, payment shall be made to Contractor, by wire transfer in accordance with the bank instructions to be provided by Contractor, within thirty (30) days following receipt of a properly supported invoice from Contractor.

Can a contractor commit a rig to a third party?

During the Primary Term and any Extension Terms, Contractor shall not contractually commit the Rig to any other party while this Drilling Contract is in effect unless the relevant time period for Operator to exercise its respective options pursuant to this Section 2.6 has expired.
