Will Ensco & Rowan merge?

Offshore drillers Ensco and Rowan have announced an all-stock merger agreement creating an offshore drilling company with 82 offshore rigs in its fleet. The two drillers have said that the merger will create a driller with the broadest geographic presence of any offshore driller in the market.

How many rigs will Rowan & Ensco have?

The Saudi Aramco partner to the ARO Drilling joint venture has consented to the combination between Rowan and Ensco. According to the statement released on Monday, the combined fleet will consist of 28 floating rigs (semi-sub and drillships) and 54 jack-ups.

How many jack-up rigs does Ensco have?

Among the combined company's jack-up fleet are seven ultra-harsh environment units and nine additional modern harsh environment rigs. The date of the merger announcement comes almost exactly one year after Ensco completed a merger with Atwood Oceanics in October 2017, becoming the largest jack-up operator in the world at the time.

Did Ensco buy Ocean Rig?

Just a little over a month ago, in September, Ensco's rival, Transocean, announced it would buy Ocean Rig in a transaction valued at \$2.7 billion. To remind, earlier in 2018, Transocean also completed the acquisition of the floater specialist Songa Offshore.
