



Logic general conditions of contract for mobile drilling rigs

Where can I find the logical oil and gas industry standard contracts?

The oil and gas industry standard contracts developed under the CRINE initiative and now administered by LOGIC are now available on-line through the LOGIC website ([www.logic-rigs.com](#)). Until now, the contracts have only been available in hard copy.

How many standard contracts does logic support?

LOGIC currently supports a suite of 11 Standard Contracts that are available for use throughout the oil and gas industry and these are currently being reviewed and updated. They cover a broad range of operations in the UKCS and are widely used across the contracting community.

What is the logic standard contracts task finish group?

This LOGIC Standard Contracts Task Finish Group was established in 2012 and reports to the Legal Issues Forum (LIF). The remit of the Work Group is to review, analyse and discuss recommendations on amendments to LOGIC's Standard Contracts and, as and when requested by the LIF, the development of new Standard Contracts.

What are the terms and conditions of a contract?

8.6 The terms and conditions of the CONTRACT shall apply to any properly authorised PURCHASE ORDER raised for WORK to commence before the CONTRACT end date or extensions thereto, and shall continue to apply until completion of the PURCHASE ORDER where this is later than the CONTRACT end date or any extensions thereto. 9.
