The contract drilling company, the US drilling arm of major drilling firm Nabors Industries, provides a range of drilling and related services, and is one of the largest contract drillers in the lower 48 states. Through strategic acquisitions and internal investments, the company has built up its operating fleet to more than 300 land drilling rigs.

Does Nabors have a robotic drilling rig?

Nabors retrofitted an existing rig (X29) with a robotic module named RZR and has successfully drilled multiple horizontal wells for ExxonMobil in the Permian Basin. In 2021, Nabors and ExxonMobil proved fully automated land drilling is possible with Nabors' newbuild R801 robotic drilling rig.
