



## Noble drilling sells rigs

Who owns Noble Jack-up drilling rigs?

Offshore drilling company Noble Corporation has completed the sale of five jack-up drilling rigs, the Noble Hans Deul, Noble Sam Hartley, Noble Sam Turner, Noble Houston Colbert, and Noble Lloyd Noble, to Shelf Drilling for \$375 million.

How many rigs does Noble Corporation have?

Noble Corporation plc is an offshore drilling contractor organized in London, England. Its affiliate, Noble Corporation, is organized in the Cayman Islands. It is the corporate successor of Noble Drilling Corporation. The company operates 38 drilling rigs including seventeen drillships, eight semi-submersible platforms, and thirteen jackup rigs.

The sale of the five rigs (the Remedy Rigs) was a part of the recently completed business combination with Maersk Drilling. Noble had to sell the five rigs to alleviate competition concerns in the UK.
