Who owns ocyan rigs?

Bondholders including AIG Asset Management, Contrarian Capital Management, Moneda and Allianz agreed to convert \$2.7 billion of Ocyan debt into capital, giving birth to a new entity responsible for owning and operating five rigs.

What will ocyan do with drillco?

In addition, Ocyan will focus on the continued development of its operations in floating production storage and offloading units ("FPSOs"), and subsea and offshore maintenance services. Ocyan will retain a 6.5% equity stake in DrillCo (as defined below) on account of its pre-EJ interests, and a seat on DrillCo's board of directors.

What is ocyan restructuring?

The Restructuring is intended to allow each of Ocyan and the Project Companies to enhance its liquidity, strengthen its short and long-term financial position and take advantage of opportunities available in the oil and gas industry.

Why did ocyan win two new offshore maintenance contracts in 2021?

Ocyan also wins two new offshore maintenance contracts. In 2021, the company incorporated the ESG vision into its corporate strategy, making short, medium and long-term commitments. ODN II is rehired by Petrobras to work on a project in the Equatorial Margin.
