Use the information below to customize your own specific accident prevention plan. At least one crew member is trained in first aid/CPR. SCBAs are inspected monthly and documented.

Document general safety practices: Review the availability of first aid kits and pre-job safety meetings. Standardize safety inspections and maintain compliance at drill locations. Conduct thorough inspections of oil and gas rigs using this checklist to enhance safety and compliance.
