Who is vantage drilling?

Vantage Drilling International is an offshore drilling contractor that operates and manages a fleet of modern, high specification drilling rigs on a worldwide basis. Since our inception in 2007 we have forged a very experienced and dynamic team of personnel from across the globe to support our worldwide drilling operations.

What happened to vantage oil rigs?

Vantage has a fleet of two ultra-deepwater drillships and two jackup drilling rigs that are contracted for most of the year. As oil prices recovered last year, the company sold three jackup rigs to ADES Arabia Holding to get financial breathing room. Vantage cut more than \$1.5 billion of debt through a bankruptcy in 2016.

Is vantage drilling recertifying its ultra-deepwater drillship?

Per Vantage Drilling's fleet status report, the rig is scheduled to move to a shipyard for recertification and upgrade following the sale. Another ultra-deepwater drillship from Vantage Drilling's fleet, Platinum Explorer, got its conditional letter of award (CLOA) with an undisclosed client extended by 30 days last month.

How long will vantage drilling manage the tungsten explorer?

As previously disclosed, Vantage will continue to manage the Tungsten Explorer for 10 years with the option to extend for an additional five years. Per Vantage Drilling's fleet status report, the rig is scheduled to move to a shipyard for recertification and upgrade following the sale.
