Regulators say the blowout that killed five workers on a Patterson-UTI rig in Oklahoma was the product of a slow-moving series of missed signals, misleading testing, and miscalculations that failed to control a natural gas influx.

How many workers have died at Patterson-UTI well sites?

OKLAHOMA CITY (AP) -- Ten workers have died over the past decade at well sites linked to drilling contractor Patterson-UTI, the same driller involved in this week's rig explosion in Oklahoma that killed five workers, federal records show.

Did Patterson-UTI drill and Red Mountain Energy have an environmental impact?

The environmental impact was minimal, and the companies involved, Patterson-UTI Drilling and Red Mountain Energy, are not well known. Still, it provided a stark warning of the risks associated with some widely used drilling practices. "Our investigation found significant lapses in good safety practices at this site.

How does a Patterson-UTI rig work?

The Patterson-UTI rig was equipped to safely manage gas produced during drilling, using a rotating control device and an orbit valve to divert mud with gas to a mud/gas separator and on to a flare that ranged from 20 ft high, to as high as 50 ft, the report said. Low-mud-weight fluid can allow faster drilling and limit formation damage.

How many Patterson-UTI employees died in Texas rig accidents?

The report devoted an entire section to the company and 13 employees who died in Texas rig accidents over a nearly four-year period. A separate AP analysis published in 2008 showed at least 20 Patterson-UTI employees died on the job between 2002 and 2007. No other oil and gas company had more than five fatal accidents during that span.
