Does Patterson-UTI have a high-spec drilling rig?

Patterson-UTI operates a high-spec drilling rig, specifically the Apex PK model. Patterson-UTI Energy, Inc. (NASDAQ: PTEN) is a drilling specialist in the United States that revealed Tuesday it will add 16 super-spec rigs to its 150-rig domestic fleet.

Why did a Patterson-UTI rig blowout kill 5 workers?

Regulators say the blowout that killed five workers on a Patterson-UTI rig in Oklahoma was the product of a slow-moving series of missed signals, misleading testing, and miscalculations that failed to control a natural gas influx.

Is Patterson-UTI a good oil rig company?

Patterson-UTI, an oilfield services company based in Houston, TX, was founded in 1978. It is a good company suited for being part of a bigger well service rig business or as a specialized independent firm. The company came into its current form following a merger between Patterson Energy, Inc. and UTI Energy Corporation.

Why did Patterson-UTI buy Pioneer drilling rigs?

Patterson-UTI's CEO, Andy Hendricks, announced, "As a leading provider of contract drilling services in the United States, we are proud to announce this transaction." The company will benefit from Pioneer's high-quality fleet of 17 drilling rigs in the country, 16 of which are super-spec.

When did Patterson Drilling acquire UTI Energy?

In 2001, Patterson Drilling acquired UTI Energy and renamed the company Patterson-UTI Energy. In September 2014, the company acquired Texas-based pressure pumping assets. In September 2016, the company acquired Warrior Rig.

How many rigs does Patterson-UTI have in the US?

Patterson-UTI plans to expand its US super-spec rig fleet to 166 units. Nearly one-half of these rigs will be able to run on alternative power sources. The transaction will also add eight pad-capable rigs to the firm's international operations in Colombia.
