Who owns Petroserv oil rigs?

A special purpose vehicle PS Marine Holding will take over all Petroserv's assets via a share purchase of its subsidiary, Universal Energy Resources for an undisclosed sum. Founded in 1972, Petroserv currently owns and operates a fleet of four drilling rigs.

What happened to Petroserv?

The transaction was consummated on May 8, 2024. Petroserv and its remaining dormant entities will be wound down in due course. Founded in 1972, the Petroserv Group was a leading Brazilian owner, operator, and manager of offshore drilling rigs.

When did Petroserv marine acquire universal energy resources?

After entering into a share purchase agreement (SPA) with Petroserv Marine on March 8, 2024, regarding the acquisition of all outstanding shares in Universal Energy Resources, the acquisition closed on May 8, 2024.

Does Ventura offshore own Petroserv marine?

Earlier this year, Ventura Offshore got its hands on the business of Petroserv Marine, which not only has a strong foothold in the Brazilian deepwater market - built up over 25 years - but has also operated in West Africa and Southeast Asia.

Who owns DS Carolina & SSV Victoria rigs?

Currently, the Brazilian firm owns and operates the DS Carolina drillship and the SSV Victoria semi-submersible drilling rig. The company also manages the Zonda drillship and the SSV Catarina semi-submersible rig.
