



## Previously acquired drilling rigs

What are dedicated drilling rigs not considered as?

Note: Dedicated Drilling Rigs are not considered to be nor defined as "Cranes" in the US and Canada. However, in the following resources, the reader will note that there are numerous references to mobile cranes and not dedicated drill rigs per se.

Did GDI buy Seadrill jackup rigs?

Qatar-based Gulf Drilling International (GDI) has renamed three jackup rigs it purchased from Seadrill earlier in 2024. GDI agreed to acquire the 400-ft rated West Castor, West Telesto, and West Tucana for \$338 million in May 2024, with the transaction closing in June.

What rigs are renamed after Seadrill?

The ex-Seadrill rigs, all operating under contracts in Qatar, have been renamed Al Bidda (formerly West Castor), Laffan (formerly West Tucana), and Mesaieed (formerly West Telesto). Al Bidda is contracted to QatarEnergy LNG until late April 2026.

When will the super spec triple rig be ready for work?

The Corporation anticipates that the super spec triple rig will be ready for work in mid-2023 subsequent to an additional anticipated investment by the Corporation of approximately \$5 million to upgrade, refurbish and recertify the super spec triple.
